### BID NOTICE UNDER OPEN DOMESTIC BIDDING

1. The **National Agricultural Advisory Services (NAADS)** has allocated funds to be used for the acquisition of tilapia fish fingerlings, mirror carp fish fingerlings, African cat fish fingerlings and fish feeds under framework contract for a period of three (03) years.
2. NAADS Secretariat invites sealed bids from eligible and suitably qualified bidders for supply of tilapia fish fingerlings, mirror carp, African cat fish fingerlings and fish feeds under framework contract for a period of three (03) years.
3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003.
